Glossary of Acronyms

ACER: Agency for the Cooperation of Energy Regulators.

REMIT: Regulation (EU) No 1227/2011 of the European Parliament and the Council on wholesale energy market integrity and transparency.

NRA: National Regulatory Authority.

1 Notification according to Article 3(4)(b) of REMIT

In order to create a new Notification according to Article 3(4)(b) of REMIT, you will be required to enter the information written below. Some of them are mandatory: they are highlighted in bold and have an asterisk next to them.

1) Details of the notifying party	
a) Name of the market participant*	Mandatory. Name of the Market Participant (either company name if legal person or full name if natural person). Maximum size: 200 characters.
b) ACER Code	Unique code of the Market Participant using the ACER registration code received while registering under REMIT (e.g. A0000603S.SI). Size: 12 characters.
2) Contact person	
a) Surname, forename*	Mandatory. Surname and forename of the contact person at the Market Participant. Maximum size: 100 characters.
b) Address*	Mandatory. Full address of the site of work of the contact person. Maximum size: 200 characters.
c) Phone/Fax*	Mandatory. Telephone number (including international and national codes) to the contact person. International access codes shall begin with "+". Maximum size: 30 characters.
d) E-mail*	Mandatory. Full email address of the contact person. Maximum size: 300 characters.
e) Retype E-mail*	Mandatory. E-mail check. Maximum size: 300 characters.
3) Type of Market Participant entering into transaction	
a) Type of market participant entering into transaction*	Mandatory. Choose between: <ul style="list-style-type: none"> ▪ Electricity producer ▪ Natural gas producer ▪ Operator of natural gas storage facility ▪ Operator of LNG import facility ▪ Other (provide further information in field 6.c)
4) Competent Authority	
a) National Regulatory Authority*	Mandatory. Select from a list of NRAs to choose which NRA(s) to notify. Please note that NRAs selected will receive your notification under Article 3 (4) (b) of REMIT. To choose multiple NRAs press and hold down the Ctrl key then click each NRA that you want to notify.
b) Other information on the National Regulatory Authority	Insert here further information regarding the selected National Regulatory Authority / Authorities. Maximum size: 2000 characters.
5) Identification of the inside information concerned	

a) Name of the facility*	Mandatory. Identification of the inside information concerned. Maximum size: 4000 characters.
b) Installed capacity of the facility	Maximum size: 200 characters.
c) Unavailable capacity	Maximum size: 200 characters.
d) Dates of the unplanned outage	Date range (including hours) of the unplanned outage.
e) Other details	Maximum size: 4000 characters.
6) Identification of the transaction concerned	
a) Contract ID	ID of the contract using a unique code identifier provided by the market place or counterparties. This field could be enabled/disabled by ACER; if enabled, it will be mandatory. Maximum size: 40 characters.
b) Transaction ID	ID of the transaction as assigned by the organised market place of execution, or by the two market participants in case of bilateral contracts. This field could be enabled/disabled by ACER; if enabled, it will be mandatory. Maximum size: 52 characters.
c) Other Details*	If fields "Contract ID" and "Transaction ID" are disabled, this field will be mandatory. The information reported shall include: <ul style="list-style-type: none"> - The markets concerned - The type of products involved (example: intraday H09 for delivery on xx/yy/zzzz in xx) - The time, volume and price of the transactions/orders - the precise identification of the wholesale energy products bought and sold, the price and quantity - The timeline of the events - The type and characteristics of the order - The potential of cross border impact - The potentially affected financial products. Maximum size: 4000 characters.
